This Privacy and Cookie Notice explains how Trading Compliance Limited uses personal data. Trading Compliance Limited is a company registered in England and Wales (03460182) and a registered Data Controller with the UK ICO (ZA389670)

How do we process personal data?

1. Visitors To Our Website

We record your IP address, pages you visit and date/time stamp. This is a legitimate interest to help maintain the security and performance of the website. The information is not used to identify visitors and is deleted after two years.

You can use our contact form to initiate business conversations with us. As a legitimate interest, we retain this data for two years.

Our website is hosted by <u>Huga Digital Marketing</u> in the UK and we use <u>Google Analytics</u> which uses cookies to monitor how visitors interact with our website. Cookies are small text files that are placed on your computer to store information about your use of our website.

2. Customers and Partners

We are a business-to-business organisation. We work with many organisations and retain contact details of people we speak to in those organisations as a legitimate interest. We will delete or restrict use of those details if requested or if we believe they are no longer relevant.

Our email servers, file services, mailshots and CRM are hosted by <u>Intermedia</u>, <u>DropBox</u>, <u>Mailchimp</u> and <u>Capsule</u> respectively, either in the UK, EU or in the US under the UK/US Privacy Shield.

3. Employees

When individuals apply to work at our firm as staff or contractors, we will use the information that is provided to assess the applicant. We will obtain consent before requesting references or other background checks. We will delete data from unsuccessful candidates after 2 years.

For employees and sub-contractors, we will maintain employment records for a variety of reasons including legal (e.g. employment, AML and tax law), contract (e.g. bank details) and legitimate interest (e.g. performance reviews). After the employment ends, we will delete data that is no longer required after 7 years, but retain some of the information that may be required for references or legal reasons.

Protecting Personal Data

Security of personal data is very important to us. We use a wide range of organisational, technical, physical and operational controls, which are assessed for effectiveness on a regular basis.

We only process personal data in the UK, EU or in the US under the UK/US Privacy shield.

Individual's Personal Data Rights

We fully respect your rights to request that we:

- Allow you to opt-out of any process that you previously consented to, at any time.
- Provide a copy of data we hold on you, or to pass it to a third party on your behalf.
- Amend, delete or restrict processing of your data.
- Explain and review any automated decision making or profiling.
- Provide further information about our processing activities.
